#### II. Enrollment Requirements and Criteria

1. Candidates who have passed either the state or an international matriculation exam may enroll in the first cycle of academic studies, academic studies in the field of arts, and the first cycle of professional studies.

In the 2025/2026 academic year, candidates who acquired a certificate for completed four-year secondary education in the 2019/2020 school year may enroll in the first cycle of academic and professional studies, as well as academic studies in the field of arts as per the Decree with Legal Force for Amending the Law on Higher Education during a State of Emergency.

Also, any candidate with a four-year secondary education completed under the regulations applicable prior to the introduction of the state matriculation exam (prior to the 2007/2008 school year) may enroll in the first cycle of studies.

- 2. Candidates shall be enrolled as either full-time state-funded students or full-time students providing co-payment for their studies. Also, irregular students may enroll in the first cycle of studies at faculties if the nature of the study program allows for this.
- 3. Candidates who have completed higher education at related faculties or colleges may enroll in the first cycle of studies at faculties. Such candidates shall be enrolled outside the state-funded quota, and their share shall not exceed 10% of the total number of full-time students, specified in this Competition, at the respective faculty.

The ranking of aforementioned candidates shall be performed based on the grades achieved in previously completed higher education, except for specific study programs where knowledge and skills testing is required for enrollment. Relatedness of faculties shall be determined and announced by the faculties.

Candidates specified in this item, including candidates specified in Chapter V of this Competition shall provide co-payment for their studies.

#### **III. Candidate Selection**

1. To implement the Competition for Enrollment, the Faculty's Teaching and Scientific Council shall establish a Competition Commission, while the

Faculty of Architecture and art faculties shall also establish Commissions for knowledge and skills testing.

- 2. To monitor the implementation of the Competition, the Rector's Board shall establish a University Competition Commission. The University Competition Commission shall monitor the implementation of the Competition at faculties; ensure consistent compliance with the Competition provisions and provide instructions and opinions during the implementation thereof. The University Competition Commission shall adopt Guidelines on the implementation of the Competition.
- 3. The ranking of candidates shall be carried out by Competition Commissions at individual faculties.
- 4. The Competition Commission shall, on the faculty's notice board, publish a preliminary ranking list, including the points earned from the average grade in secondary education and the results from the knowledge and skills testing for study programs where such testing is carried out.

Upon the publication of the preliminary ranking list of candidates, any candidate shall have the right to file a complaint thereto within 24 hours. Otherwise, such candidates shall lose the right to complain in any further procedure regarding the results published. This complaint shall relate solely to technical omissions or errors made during the calculation of points, and it shall be addressed to the Faculty's Competition Commission. The Decision of the Commission on such complaints shall be final. Decisions on complaints shall be published at faculties.

Following the expiry of the deadlines for filing complaints and resolution thereof, the Competition Commission of the respective faculty shall publish a Decision on Students' Admission (final ranking list), based on which students shall be enrolled.

The faculty shall also provide the Decision of the Competition Commission on Students' Admission (the final ranking list) to the University Rector's Office.

- 5. After the first admission round ends, faculties with vacancies shall carry out enrollments in the second or third admission round.
- 6. If any candidate who passed the entrance exam and made the final ranking list in the first admission round does not submit enrollment documents and is not enrolled during candidate enrollment, the Faculty's Competition Commission shall rerank candidates by moving the next candidates who passed the entrance exam up on the ranking list in line with the points earned.

#### IV. Enrollment of Full-time Students in the State-Funded Quota

- 1. Students shall be enrolled in the state-funded quota by paying a €200 fee in denar equivalent under the middle exchange rate of the National Bank of the Republic of North Macedonia.
- 2. Payment of such fee shall, as a rule, be made in two equal installments, when enrolling in the winter and summer semesters.
- 3. Students who retain their status of full-time students in the state-funded quota as per the Ss. Cyril and Methodius University (UKIM) Statute shall pay the fee specified in paragraph 1 of this item throughout the entire course of studies.
- 4. If during the first admission round, the final ranking list includes multiple lowest ranking candidates with the same number of points (maximum five such candidates), the faculty shall enroll all such candidates. If, on the other hand, there are more than 5 such candidates, faculties shall rank these candidates according to the following additional criteria: the relevance of the student's project assignment as part of the state matriculation exam, any prizes won at national and international competitions, members of national sports teams of the Republic of North Macedonia, any certificates acquired for proficiency in foreign languages, etc.
- 5. In the 2024/2025 academic year, members of security forces and other groups specified in the Law on Special Rights of Members of the Security Forces of the Republic of North Macedonia and Their Family Members, individuals specified in Article 23 of the aforementioned Law (Official Gazette of the Republic of North Macedonia No. 2/02, 17/03, 30/04 and 66/07, and Official Gazette of the Republic of North Macedonia No. 53/21) shall be enrolled outside the state-funded quota, with no study costs as per the enrollment requirements specified in this Competition, and

their share shall not exceed 10% of the total number of students enrolled in the study program. When applying, candidates shall exercise their right as in the previous paragraph by providing a document issued by either the Ministry of Defence or the Ministry of Interior. Any subsequent submission of such document for candidates enrolling in the first year shall not be taken into consideration.

6. The higher education institution shall not charge the co-payment amount to the following individuals:

- If unemployed, any individual up to the age of 26 who had the status of a child without parents up to the age of 18 (shall submit proof in the form of a Certificate issued by the competent Center for Social Work);
- Persons with disabilities; as per the Decree adopted by the Government (shall submit proof in the form of a Findings and Opinion of the Functional Assessment Service at the PHI Health Center Skopje, and a Decision of the Center for Social Work on Disability Type and Degree);
- If unemployed, any parent of a child up to the age of 6 (shall submit proof in the form of a Birth Certificate of the child and a Letter of Confirmation for a registered unemployed person);
- War veterans with disabilities (shall submit proof in the form of a Decision issued by the Ministry of Labor and Social Policy, Directorate for War Veterans);
- If unemployed, any individual from children's homes;
- Other individuals specified in the Decree adopted by the Government upon the proposal of the National Council.

These candidates shall be enrolled outside the state-funded quota, and their share shall not exceed **10%** of the total number of full-time students, specified in this Competition, at the respective faculty.

The co-payment amount for such individuals shall be covered by the Budget of the Republic of North Macedonia.

## V. Enrollment of Full-Time Students With a Tuition Fee

- 1. Candidates who meet the enrollment requirements, but are unable to enroll in the state-funded group of students due to quota limitations shall also be enrolled as full-time students. The ranking of this category of students shall be performed with a previously submitted statement by these candidates, stating that they agree to co-finance their studies throughout the entire course of studies.
- 2. Students enrolling in this category shall pay a €400 fee, in denar equivalent, under the middle exchange rate of the National Bank of the Republic of North Macedonia at the date of payment, in at least two equal installments.
- 3. The fee specified in the previous paragraph hereof shall be paid by students throughout the entire course of studies.
- 4. The faculty shall publish a ranking list of candidates who meet the requirements for enrollment in this category.

The list of candidates admitted in this category shall be identified by the Competition Commission based on the ranking list and Statements of

Consent submitted for enrollment in this category.

When enrolling, students in the co-financing group shall conclude a contract with the faculty on mutual rights and obligations in the implementation of the teaching and educational process.

# VI. Enrollment of Irregular Students

- 1. Candidates who meet the enrollment requirements and are employed, and candidates who, for justified reasons, cannot be enrolled as full-time students, may be enrolled as irregular students in certain study programs at the faculties.
- 2. The following shall be considered justified reasons as in the previous paragraph: a person with disabilities who is unable to attend classes; a more serious
- long-term illness, which makes it impossible to regularly attend class for more than one semester; parent of a child on maternity leave.
- 3. Irregular students shall be enrolled under the same conditions and criteria as full-time students, however they shall be ranked on a separate ranking list.
- 4. Students enrolling in this category shall pay a €400 fee, in denar equivalent, under the middle exchange rate of the National Bank of the Republic of North Macedonia at the date of payment, in at least two equal installments.
- 5. Students shall pay the fee specified in the previous paragraph hereof throughout the entire course of studies.
- 6. When applying for enrollment as irregular students, candidates shall submit a notarized M1/M2 Form, or a medical certificate specifying any of the reasons from item 2 hereof (issued by PI Ss. Cyril and Methodius University Student Polyclinic in Skopje).

#### VII. Candidates Who Completed Secondary Education Abroad

#### a) Foreign nationals

- 1. Foreign nationals shall be enrolled outside the quotas for enrollment of citizens of the Republic of North Macedonia.
- 2. Tuition fees for foreign nationals enrolling in the 2025/2026 academic year are presented in Chapter I of this Competition.
- **3.** The selection of candidates shall be performed based on the relevance of their completed secondary education for the study program they are applying for and their grades from secondary education.

Candidates applying to study at the Faculty of Architecture and at the art faculties shall undergo knowledge and skills testing as part of the selection process (II/5.b).

4. Applying and Enrollment

# Candidates specified in Chapter VII, item a) shall submit their application to the Rector's Office at the Ss. Cyril and Methodius University in Skopje within the deadlines specified in this Competition.

Candidates shall register electronically at the following e-mail address: st.student@ukim.edu.mk.

In addition, candidates shall submit the original documents to the Rector's Office of the University.

# When applying, candidates shall submit the following:

- Enrollment Application (A1 Form);
- Original certificate for completed secondary education (with an Apostille, that is, a stamp by the Ministry of Foreign Affairs for countries that are not members of the Hague Convention);
- Original certificates for each school year completed in secondary education;
- Original birth certificate;
- Original certificate of citizenship.

Student enrollment shall be performed at faculties during the third admission round.

#### When applying, candidates shall submit the following:

- Decision recognizing certificates for completed secondary education, issued by the Ministry of Education and Science of the Republic of North Macedonia;
- Student's index (booklet), student ID and application forms;
- Three photos (two 3.5 x 4.5 photos and one 2 x 3 photo);
- Payment slip of 750 denars paid for informative, IT, cultural and sports activities of students at Ss. Cyril and Methodius University in Skopje, including the wording "IKSA of UKIM", \_\_\_\_\_ (please specify the faculty offering the study program), to the giro account: 10000000063095 depositor: National Bank of the Republic of North Macedonia (NBRNM), with a Budget user account: 1600103689 788 18; Income code: 723012, Program: 41;
- Payment slip for the tuition fee paid for the respective semester

5. The University shall organize classes for studying the language in which the selected study program is taught, in parallel with regular lectures.

- For candidates who are foreign nationals, Ss. Cyril and Methodius University in Skopje shall organize a short, two-semester professional study program Macedonian Language for Foreigners, within the framework of the first cycle of studies.
  - Classes are held during winter and summer semesters and are carried out according to a special study program.

During lectures, the knowledge of the candidate is continuously assessed.

After completing the classes and acquiring 60 ECTS credits, students obtain a certificate for completing a short professional study program, issued by Blaže Koneski Faculty of Philology.

- For foreign nationals who are enrolled in study programs in English, Ss. Cyril and Methodius University in Skopje shall organize a short, twosemester professional study programme – English Language for Foreigners, within the framework of the first cycle of studies.

Classes are held during winter and summer semesters and are carried out according to a special study program.

During lectures, the knowledge of the candidate is continuously assessed.

After completing the classes and acquiring 60 ECTS credits, students obtain a certificate for completing a short professional study program, issued by Blaže Koneski Faculty of Philology.

# Candidates specified in Chapter VII, item a-5 shall submit their application to the Student Inquiry Service at the Blaže Koneski Faculty of Philology in Skopje.

# b) Citizens of the Republic of North Macedonia Who Completed Secondary Education, Fully or Partially, Abroad

1. Candidates whose parents are Macedonian emigrants and candidates who are citizens of the Republic of North Macedonia who completed their entire secondary education abroad shall be enrolled outside the state-funded quota, under a co-financing model.

At the Faculty of Architecture and art faculties, candidates specified in item 1 undergo knowledge and skill testing as part of the selection process.

The tuition fee for this category of students is €400, in denar equivalent, per academic year (as is for candidates specified in Chapter V).

With the application, candidates specified in item 1 shall submit a nostrified certificate for completed secondary education abroad.

Such candidates shall be enrolled outside the quota, but the total number of such students must not exceed 10% of the state-funded quota.

2. Candidates who are citizens of the Republic of North Macedonia and have partially completed their secondary education abroad shall be enrolled under the same requirements and criteria as candidates who completed secondary education in the Republic of North Macedonia. In addition to other documents, such candidates shall submit nostrified certificates for the secondary education completed abroad.

Candidates specified in Chapter VII, item b.1) shall submit their application with the Rector's Office at the Ss. Cyril and Methodius University in Skopje, while candidates specified in Chapter VII, item b.2) shall submit their application at the respective faculty.

# VIII. Candidates Who Passed an International Matriculation Exam and Candidates from Private Secondary Schools in the Republic of North Macedonia

- 1. Candidates who passed an international matriculation exam shall be enrolled under the same requirements and criteria as candidates who completed secondary education in the Republic of North Macedonia. Scoring of the academic achievement of such candidates is conducted according to Chapter II, 5.a.1 of the Competition. Scoring of the international matriculation exam results is carried out in the following manner: Each grade from the six externally assessed subjects is multiplied by a coefficient of 1.2. The resulting points are then summed up. A maximum of **36 points** can be earned based on subject grades. The grade from the student's project assignment as part of the state matriculation exam is multiplied by a coefficient of 0.8. A maximum of **4 points** can be earned based on this grade. A total of **40 points** can be earned from the results achieved at the international matriculation exam.
- 2. Candidates who completed secondary education in private secondary schools in the Republic of North Macedonia and passed the state matriculation exam shall be enrolled under the same requirements and conditions as candidates who completed secondary education in the Republic of North Macedonia, as per Chapter II, item 5 of the Competition.

## Candidates specified in Chapter VII shall submit their application at the respective faculty.

#### IX. Additional Quotas Established by the Government of the Republic of North Macedonia

- To ensure fair and adequate representation of students who are members of non-majority communities in the Republic of North Macedonia, higher education institutions under the Ss. Cyril and Methodius University in Skopje shall additionally enroll such students in the 2025/2026 academic year. The share of such students shall not exceed 10% of the total number of students enrolling in the first cycle of studies per faculty. Within this 10%, representation of each community will be proportionate to their share in the total population of the Republic of North Macedonia.
  - Members of the Albanian community may only enroll in regular quotas at higher education institutions under Ss. Cyril and Methodius
    University in Skopje with study programs that are also offered at the State University of Tetovo and Majka Tereza University in Skopje.

The total share of students who are members of non-majority communities—including both regular and additional quotas—must not exceed the percentage of that community's representation in the overall population of North Macedonia.
